1. YOU ARE TO MAKE A \$50.00 DEPOSIT TO THE FUND BEFORE YOUR COSTUME MATERIAL CAN BE ACQUIRED. OF THE \$50.00, \$40 WILL BE RETURNED TO YOU WHEN YOU RETURN YOUR COSTUME TO THE COSTUME CLOSET BY JUNE 1ST. \$10.00 WILL BE GIVEN TO THE COSTUME CLOSET.
2. YOUR COSTUME MUST BE RETURNED WASHED, PRESSED, AND IN GOOD CONDITION FOR YOU TO RECEIVE THE REFUND OF \$40.00 BY JUNE 1ST.
3. PARENT/GUARDIAN AND DANCER MUST SIGN AND AGREE TO THE TERMS OF THIS CONTRACT.
4. YOU ARE ALLOWED TO PUT A HOLD ON YOUR RETURNED COSTUME FOR THE FOLLOWING YEAR OF DUTCH DANCING, HOWEVER YOUR COSTUME STILL MUST BE RETURNED TO THE CLOSET BY JUNE 1ST.
5. YOU DO HAVE THE OPTION OF PURCHASING YOUR COSTUME AND CAN SPEAK TO ANY PERSON INVOLVED WITH THE CLOSET AS YOU MAY QUALIFY FOR A PAYMENT PLAN.
6. THERE IS THE POSSIBILITY THAT YOU MAY HAVE TO ACQUIRE YOUR SEAMSTRESS SO LET US KNOW IF YOU HAVE A MOTHER, GRANDMOTHER, AUNT, NEIGHBOR, OR SOMEONE IN MIND WHO IS QUALIFIED TO SEW YOUR COSTUME.
